- Mr. Mohmad IshaqWani (DIN:08944038) was appointed as an additional director on 06thNovember 2020 to hold office till the next Annual General Meeting and the same was approved by the board in their meeting held on 06th November 2020.
- Mr. RigzianSampheal (DIN:08157221) was appointed as a director of the bank in the board meeting held on 22ndDecember 2020to fill up the Casual Vacancy caused due to the resignation of Mr. Sonam Wangchuk, (DIN: 07662456).
- Mr. Zubair Iqbal, (DIN: 08742685) ceased to be Directror upon withdrawal
 of his nomination by the Government with effect from 3rdMarch, 2021 and
 the same was taken on record by the Board in their meeting held on 23rd
 March, 2021.
- 13. Being a Government Company, the auditors are required to be appointed bythe Comptroller and Auditor-General of India within a period of 180 days from the commencement of the financial year. The Auditors so appointed shall hold office till the conclusion of the annual general meeting as per the provisions of Section 139 of the Act. There was no such instance of casual vacancy of the auditor.
- 14. During the year approvals wherever required weretaken from the Central Government, Tribunal, Regional Director, Registrar, Court or such other authorities under the various provisions of the Act.
- 15. Being a Banking Company, acceptance, renewal and repayment of deposits are not applicable;
- 16. Being a banking Company, Acceptance of deposits received from public shall not be deemed to be borrowings within the meaning of clause c of Section 180(1)(a) of the Companies Act, 2013. The borrowings made by the Bank by issue of the debentures are within the limits specified in the act.
- 17. Being a Banking Company, the provisions of Section 186of the Actrelating to giving of loans and making of investments or guarantees given or providing of securities to other bodies corporate or persons are not applicable.



18. During the period under review, the Bank has sought the approval of members by passing a special resolution in the Annual General Meeting held on 28th September 2020 for Alteration of certain regulations of the Articles of Association which were subject to the approval of the Reserve Bank of India & the same has been mentioned in the Explanatory Statement pursuant to Section 102 of the Companies Act, 2013. However, Form MGT-14 with regard to Alteration of Articles of Association was filed on 15th February, 2021.

The bank has altered the Capital Clause of its Memorandum of Association by increasing its Authorized Capital from Rs.95,00,00,000 divided into 95,00,00,000 equity shares of Re.1/- each to Rs.250,00,00,000 divided into 250,00,00,000 equity shares of Re.1/- each by passing a Special resolution in the Annual General Meeting held on 28th September 2020.
