- **6)** Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.
- 7) The interested bidders who may have submitted their **EMD** not below the 10% of reserve price through online mode/DD before 04.00 P.M. of 07.05.2024 shall be eligible for participating in the e-auction. The e-auction of above property would be conducted exactly on 08.05.2024 from 01.00 P.M to 03.00 P.M by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.5,000/- (Rupees Five Thousand Only).
