1. Appointment as Scrutinizer:

3. Remote E-voting:

Agency: The Bank had appointed Karvy Fintech Private Limited as the agency for providing the remote e-voting platform.

Remote E-voting: Remote E-voting platform was open from 9 am (IST) on 23rd September,

2019 to 5 pm (IST) on 25th September, 2019 and members were required to cast their votes

electronically conveying their assent or dissent in respect of the Five (5) Ordinary Resolutions

and Six (6) Special Resolutions, on the e-voting platform provided by Karvy Fintech Private

Limited.

4. Voting at the AGM:

The Bank had made arrangements for voting by Ballot Paper at the venue of the AGM. The

Bank's management was responsible for ensuring the compliance with the requirements of the

Companies Act, 2013 and Rules relating to E-voting and Resolutions contained in the Notice

dated 10th August, 2019 sent to the shareholders of the Bank.

As a scrutinizer, my role in the E-voting process is restricted to make a Scrutinizer's Report of

the votes cast in "favour" or "against" the resolutions based on the E-voting of shareholders of

the Bank from the reports generated from the E-voting system provided by Karvy Fintech

Private Limited and from the physical ballot voting process conducted on the day of the AGM.

5. Counting Process:

As soon as the Chairman announced the conducting of the Ballot paper, I had locked the empty

polling box in the presence of two witnesses. After completion of the Voting by ballot I

unlocked the polling box in the presence of two witnesses.

I then unblocked the remote E-voting results on the Karvy Fintech Private Limited E-voting

platform before the same two witnesses who are not in employment of the Bank and

downloaded the e-voting results.

6. Results:

I observed that:

a) 143 Members had cast their votes through remote e-voting.

b) 58 Members had cast their votes through Poll.
