# CUET results out today, new scoring system used

**NEW DELHI:** The National Testing Agency (NTA) will release the results of the maiden common university entrance test for undergraduate admissions or CUET-UG on Thursday, officials said, adding that the result will be prepared using 'equipercentile method' to normalise scores of candidates across different phases of the exam.

The NTA on Wednesday also reopened the correction window to allow candidates to edit their personal details till 10 am on Thursday.

The debut edition of CUET-UG was conducted in six phases between July 15 and August 30 by the NTA. The exam has been conducted across 489 centres in 259 cities across the country and 10 foreign cities.

A total of 1,490,000 candidates had registered for the examination and consolidated attendance of 60% was reported across six phases.



NTA said 1,490,000 candidates registered for the exam and consolidated attendance of 60% was reported.

According a statement issued by NTA on Wednesday, a committee headed by senior professors from Indian Statistical Institution (Delhi centre), IIT Delhi and Delhi University, had detailed deliberations and decided to use the 'equipercentile method' to compute CUET-UG scores.

According to NTA, under the new method, the percentile for each candidate is calculated using the raw marks of the candidate, as compared to the raw marks of others in the same session. "Let us say, in a given shift, 100 students have appeared for the test. We sort their marks in decreasing order. Let us assume one student among these 100 has scored 87 % marks. Now, let us assume that 80 out of 100 students have secured less than or equal to 87% marks. The percentile of this student with 87%

marks would be 80/100=0.8. The percentile so calculated, will always be between 0 and 1 and it is usually rounded off to the requisite number of decimal places," the agency said.

The agency further used a method called interpolation to mark students for the shift they did not appear for. "Interpolation is a mathematical way of estimating missing marks of the students absent in one shift because they already took the test in the other shift," it said.

"Each percentile value of the candidates is sorted in descending order having marks for both shifts — raw marks and interpolated marks. Raw marks are available in the shift where the student has written the test and interpolated marks are estimated in the other shift... For each student, we then calculate the average of raw marks in one shift and marks obtained using interpolation in the other shift This will give normalised marks for the corresponding percentile of each candidate," it added.

**PUNE:** State revenue minister Radhakrishna Vikhe-Patil and higher and technical education minister Chandrakant Patil chaired a special meeting on land deed registration at Mantralaya on Wednesdav.

During the meeting, it was discussed that complaints were received about non-registration of fragmented land parcels and flats within grampanchavat limits in the state due to which common flat holders were facing difficulties. It was suggested that the department of Inspector General of Registration and Controller of Stamp (IGR) should immediately submit a proposal regarding the immediate commencement of registration until the oppressive conditions in gunthewari-based system are

removed. The officials termed it as a

positive decision. Nitin Kareer, principal secretary of revenue department; IGR Šhravan Hardikar, officials of revenue and registration departments attended the meet.

Both the ministers stated that the High Court had not given any stay to Article 44/1 (i) of the Maharashtra Registration Rules, 1961 and expressed their belief that the registration of deeds will start soon and ordered officials

to submit a proposal. The meeting also discussed whether the law can be changed in the next assembly session so that common people get permanent relief. Also, during the extension of Gunthewari Act of 2001, there were very few cases of Gunthewari within Municipalities or PMRDA limits due to the imposition of oppressive conditions and exorbitant fines. letters@hindustantimes.com **HYDERABAD:** The fire in a Secunderabad hotel that claimed the lives of eight people on Monday night is likely to have started from an electric scooter that was being charged in the basement, a senior Hyderabad Police officer said on Wednesday, based on CCTV footage from the establishment.

Late on Monday, a fire broke out in the Ruby Pride Luxury Hotel in Secunderabad, claiming eight live. An electric 2-wheeler showroom is located in the cellar of the building, where, according to police, a vehicle caught fire while it was being charged.

"The building is equipped with 32-channel CCTV cameras, of which, 25 cameras are functioning. A study of the footage obtained from them after the mishap pointed out the origin of fire and it appears that the smoke first emerged from an e-bike kept for charging," deputy commissioner of police (North Zone, Hydera-

She added that the police are awaiting reports from the fire department, the electricity department, as well as the forencause of the fire.

**MUMBAI:** The Anti-Narcotics Cell of Mumbai police has arrested the owner of a Ambarnath factory where one Prem Prakash Singh allegedly synthesised mephedrone and pumped it into the illegal drug market. This is the eighth arrest in the ₹2,000-crore drug haul case.

Singh and five of his associates were arrested in August and the agency had seized 705 kg mephedrone from a commercial building owned by Singh in Nalasopara. The police also raided a factory in Gujarat, seizing another 513 kg drug and arresting the owner.

According to the police, Jinendra Vora, 54, owner of Namau Chemicals Private Limited, had been under the scanner ever since his name came up in Singh's interrogation. He was called to the ANC's Worli unit on September 10 and arrested. His manager, Kiran Pawar, has already been arrested.

#### J'KHAND MAKES **1932 BASE YEAR** FOR DOMICILE, **GIVES 77% QUOTA**

**RANCHI:** The Jharkhand cabinet, led by chief minister Hemant Soren, on Wednesday approved two bills, one fixing land records of 1932 as the basis for domicile in the state and another to increase reservation in jobs across categories to 77%.

The cabinet also approved proposals to send these two bills after ratification from the state assembly to the Centre to include them in the Ninth Schedule of Constitution, Jharkhand cabinet secretary Vandana Dadel said. Ninth Schedule shields a law from judicial review.

"The cabinet has approved the 'Jharkhand definition of local persons and for extending the consequential, social, cultural and other benefits to such local persons Bill, 2022'," Dadel said after the cabinet meeting chaired by Soren. "People who have their names of their ancestors' name in the khativan (land records) of 1932 or before will be considered as a local inhabitant of Jharkhand.'

Jharkhand BJP Deepak Prakash said, "We are studying the cabinet note. We will discuss it with our leaders.'
